



## Charlie Lewis Proffitt

June 30, 1943 - September 4, 2025

Charlie Lewis Proffitt, age 82, of Premier, VA, passed away on Thursday, September 4, 2025, at 12:05 AM with his family by his side.

Born in Buchanan County, VA. He was the son of the late Ocie “Belle” Marie Davis and Henry Melvin Proffitt.

Early in his life, he moved to Michigan where he worked for the Ford Motor and Chrysler Motor company for many years, but he eventually moved back to his hometown and took a job working for underground mining companies, such as Beatrice Coal Co., Island Creek Coal Co., and Jewell Smokeless where he was a powder man drilling into the rock and setting charges. After getting injured in a rock fall that ended his mining career, he focused on his children, family, and friends. He was of the Pentecostal Holiness faith.

Charlie was preceded in death by his parents, Henry Proffitt and Ocie Belle Marie Proffitt; two children, Baby Poffitt and Donnie Proffitt; brothers Chester, Melvin, Hubert, and Brady Proffitt; and sisters, Jean Dye, Darlene Ball, and Georgia Brown; and his first wife and mother of his children, Linda Lou Horn Proffitt.

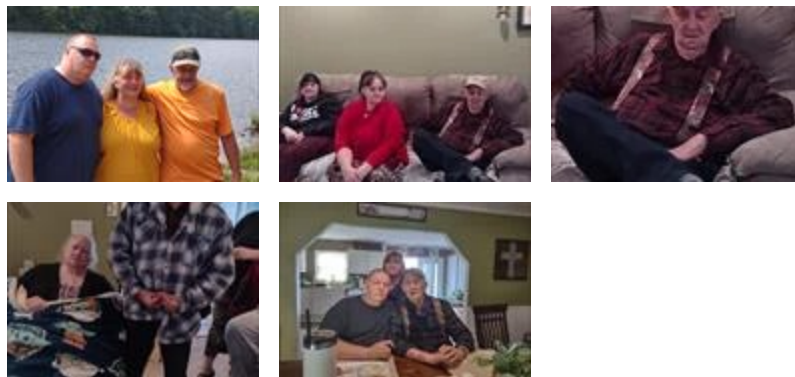

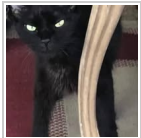
